

# The Workplace Active Certification project: First step questionnaire

### **SCOPE**

The Workplace Active Certification (WAC) is aimed at European organisations (companies, institutions, federations, associations, etc.) that promote health and well-being at work through physical activity, and which wish to have their approaches and initiatives recognised and continuously improved.

The Workplace Active Certification is accessible to any type of organisation in the European Economic Area, irrespective of its size, location, culture, sector of activity, social and economic situation.

The first-step questionnaire, accessible to any companies, will be used to further identify and understand what already exists within your organizations, which will allow us to fine-tune the WAC certification criteria taking this into account. It can also be an opportunity to identify good practices that can be shared within the WAC network of partners and users. A first threshold needs to be achieved to access the second stage.

#### Remember:

- It is important that you answer the questions by outlining <u>only what is currently done</u> in your company, not what you think should or could happen. Therefore, the person responsible for supporting your physical activity/sport initiatives should answer the questionnaire.
- The survey usually takes about 45 minutes to complete. We strongly recommend **setting aside 60 minutes** for this task, focusing **solely on this task**, and **completing it in one session**. Should you have any problem or get interrupted, you can continue from where you left the survey by logging in again using the same link.
- The information provided in the online questionnaire as well as the information/documents sent by email will be centralized at the University of Copenhagen (WAC Partner) and made available to the WAC Partner in your country so that they can read it before the video call. They will be treated confidentially within the unique framework of the WAC project.
